# **RULES AND REGULATIONS**

### 1. Admission terms.

In order to enter and stay in the campsite, you must be authorized by the manager. By staying on "Le California" campsite ground you implicitly agree to the present rules and regulations. Failure to comply with the terms may result in the eviction of the concerned individual(s), backed by police force if needed. No one can take up residence.

### 2. Police formalities.

All occupants staying at least one night must beforehand show the manager or his representative their identification, and fill the required police formalities. Unaccompanied minors under 18 years old will only be allowed with a written permission from their parents, and accompanied with an adult that must assume the full responsibility for the child.

### 3. Settling.

All the equipment, including tents and caravans, must be set up at the pitch designated by the manager. Regarding the rental of accommodation, it is strictly forbidden to set up a tent on the wooden terrace or on the plot for safety reasons. Arrivals are from 4 p.m. The pitches must be freed before 12:00 (pm). The rentals before 10:00 (am). These locations must be left in clean condition. In terms of rental accommodation, it is strictly forbidden to set up a tent on the wooden terrace or on the plot for security reasons.

### 4. Reception.

Information about the campsite services, restocking possibilities, sports installations, surrounding tourist attractions, and useful addresses are available at the reception's office.

#### 5 Views

These rules are posted at the entrance of the campground and at the reception desk. It is given to each client that requests it. To campgrounds classified the rating category with tourism or leisure and mention the number of tourism and leisure locations are displayed. The prices of various services are provided to customers under the conditions laid down by order of the Minister for Consumer Affairs and available at the reception.

### 6. Departure arrangements.

In the event of an early departure, customers are invited to notify the reception desk the day before departure to make an appointment for the inventory and complete the end-ofstay formalities.

#### 7. Noise and silence.

Occupants are encouraged to avoid any noise or discussion that could disturb their neighbors. Sound equipment must be adjusted accordingly. Closing of car doors and trunks must be as quiet as possible. Dogs and other animals must never be left free-roaming in the campsite. They should never be left at the campsite, even locked in, without the presence of their owner, who is legally responsible.

## 8. Guests.

After being authorized by the manager or his representative, visitors may be admitted to the campsite under the responsibility of the campers who receive them. The client may receive one or visitors to the home. Visitors are required to pay a fee. Campgrounds benefits and facilities are accessible to visitors. However, the use of such equipment can pay on a rate that is the subject of a display at the entrance of the campground and at the reception desk. Visitor cars are prohibited in the campground, access to swimming pools is prohibited to any visitor.

#### 9. Traffic and vehicle parking.

The speed limit inside the campsite is 10 km/h (6 mph). During the season, traffic is prohibited between 23:30 and 07:30 (am). Only vehicles belonging to the occupants are allowed in the campsite. You are allowed to park only in the space allocated to the rental. In the evening, the parking lot is reserved to the people going out after 20:00 and coming back before 23:30 (closing gate time).

### 10. Maintenance and aspect of facilities.

Everyone must be careful not to cause problems with the campsite's cleanliness, hygiene and aspect. It is forbidden to throw polluted water on the ground or in the gutters. Caravans' occupants are obliged to throw their waste water in the intended facilities. Garbage, any kind of waste, and papers must be put in trash cans. It is strictly forbidden to use the campsite's water to wash one's car. Car washing must be done with the trays provided for this purpose. Laundry must be hanged out on clothes horses. However, it will allowed to be hanged out near the shelters until 10:00 (am), provided it doesn't disturb neighbors and is unobtrusive. It will never be put on trees. Flower beds and plants must be preserved, campers must not hammer nails into trees or cut branches. Occupants must not mark out their pitch with their own equipment, nor by digging. People are responsible for any degradation committed to the vegetation, the ground, or facilities. Occupants must keep their pitch in the same condition it was when they arrived.

#### 11. Safety.

A) Fire safety: open fires (wood, charcoal, etc.) are strictly prohibited. Camping stoves must be kept in good condition. It is forbidden to use electrical devices with a power greater than 1000watts. (hair dryer, electric barbecue, fryer etc...). Fire extinguishers are available to everyone. In case of fire, promptly notify management. A first-aid kit is available at the reception. Charcoal barbecues are forbidden: only bottled gas or electric barbecues are permitted.

B) Theft: management is only responsible for the items left at the reception. Immediately notify the manager of any suspect person inside the campsite. Even though security is ensured, occupants are advised to use of the usual precautions with their equipment.

#### 12. Games.

Occupants must not organize any violent or troublesome games near installations. The meeting room must not be used for turbulent games.

### 13. Vehicle storage.

Unused equipment will only be accepted on the pitch after the management's consent, and only at the location designated by the manager. The vehicle storage will be charged according to the price displayed at the reception.

## 14. Breach of the rules of procedure.

In the case where a resident disturbs the stay of other users or does not respect the provisions of these rules, the manager or his representative may orally or in writing, if it deems necessary, give notice thereof to stop disorders .dropoff window In case of serious or repeated breach of the rules of procedure and after notice by the Manager comply, it may terminate the contract. In case of criminal offense, the manager may call the police. Violation of any rules as to allow for an immediate eviction without payment or reimbursement of the remaining stay.

#### 15. Animals.

Small animals under 6 kg are allowed, up to one per pitch. They must be tattooed, vaccinated (anti-rabies required), and kept on a lead/leash. First and second class dogs are not allowed inside the campsite. Vaccination record has to be shown upon arrival to the campsite.

#### 16 Pool

Access to the pools is limited to the campsite's occupants. Any person unable to prove their stay at "Le California" will be asked to leave the aquatic park. For health reasons, only swimsuits are allowed; shorts, Bermudas and other clothes are forbidden. It is strictly prohibited to run around the pools, or take part in violent games in or around the water. Management has the right to exclude any offenders. Children are under their parents' responsibility. In case of accident, management declines all responsibility.

## 17. Sauna et Jacuzzi.

Sauna access is not allowed to children: only people over 18 are allowed. Jacuzzi is open to everyone; children must be accompanied by an adult. In case of accident, management declines all responsibility if those rules are violated.
